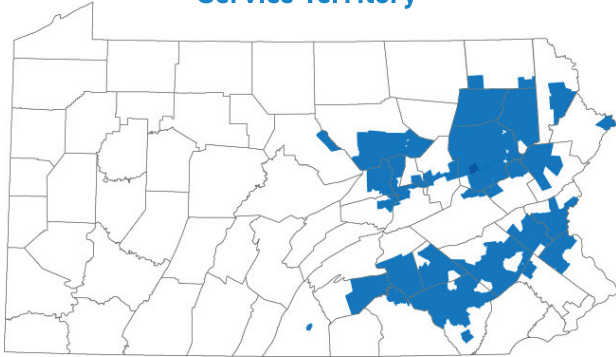


Service Territory



In order to be eligible, UGI Save Smart New Homes Must

- ✓ Be located in UGI Gas or UGI Penn Natural Gas service territories
- ✓ Have a certificate of occupancy issued on or after Jan. 1, 2018
- ✓ Each home must be at least 30 percent more energy-efficient than current codes and federal standards require, as documented by a HERS rating. This includes ENERGY STAR certified homes.
- ✓ Have natural gas space heating
- ✓ Be a single-family detached, a single-family attached, a modular home, or a residentially metered unit in a multifamily building, five stories or less. Manufactured homes are not eligible.

Take Advantage for Your Business

The UGI Save Smart New Homes Program offers builders and developers a way to stand out from the competition. The program will help you identify and implement best practices in energy-efficient construction, assist you with marketing and advertising new construction projects, and provide you with financial incentives.

Certified HERS Raters provide the required third-party verification for energy savings, participation in the program, and ultimately determine incentive eligibility for each participating new home. Working with a participating HERS rater in the early stages of home design and construction will enable you to maximize the incentive you receive per home. The associated costs of hiring a HERS rater to provide evaluation of eligibility is typically more than covered by program incentives, especially when paired with electric utility incentives.

Builders and HERS raters must complete an online participation agreement in order to receive incentives through the UGI Save Smart New Homes Program.

Incentives Available

UGI Save Smart New Homes offers participating builders incentives for every MMBtu saved.

Tier 1: Code Plus

Eligibility Requirement	Incentive to Builder
HERS Rating + 30% savings over code	\$20 per MMBtu* (uncapped)

Tier 2: ENERGY STAR 3.0

Eligibility Requirement	Incentive to Builder
HERS Rating + ENERGY STAR certification+ 30% savings over code	\$30 per MMBtu* (uncapped)

*Annual MMBtu savings are determined by comparing the newly constructed home against a code-minimum custom UGI reference home using RESNET-accredited rating software.
